Re: *Index to Letters for Bodies of Elders*

Dear Brothers:

We have posted a revised *Index to Letters for Bodies of Elders* (S-22) in the “Forms” section on jw.org. The May 1, 2014, version of the index should be removed from the congregation file and be destroyed.
